Re: Determining "bona fide religious convictions"

Thank you for your courteous and timely response dated 8/28/2006 in regard to my previous FOIA request "Documented criteria and procedures for determining "bona fide religious convictions" et al." dated 8/11/2006. However, certain items appear to be missing from your reply, and the items received were not sufficient to qualify as those items requested.

Received were the following:

- A. Pages OP-242 and OP-243 from Section B of the Field Operations Manual, June 1, 2004
- B. Affidavit Form
- C. Sec. 1030.63 Religious Exemption for Social Security Numbers from the Administrative Code

"A" describes:

- Special numbers for religious objectors
- Only 2 religious groups whose faith will not permit its members to obtain the SSN
- Procedures for applicants to supply information
- Procedures for facility personnel to complete the application and supporting documents
- Department procedures following approval or rejection

"A" does not contain any information regarding department procedures and criteria for:

- · Determining what are bona fide religious convictions
- Determining which "certain religious groups" have bona fide convictions
- · Accepting or rejecting an applicant's religious convictions

"B" is an empty form for stating one's convictions with a religious leader's affirmation, and does not list any organizations or bona fide convictions by which to qualify an applicant.

"C" reiterates "A" except that it also has instructions to verify the applicant's information in "B" with the religious organization to satisfy a bona fide religious conviction.

It is therefore understood that the ONLY procedure and criteria for determining bona fide religious convictions and whether an applicant has bona fide religious convictions is by the attestation of the religious leader and subsequent verification by the religious organization. It is understood that the burden of proof is NOT with the State but with the religious leader and the religious organization. This prevents discrimination and religious preference; that no ad hoc decisions or preference can be made by the department employee or official. If this understanding is incorrect, please inform me as to the correct understanding. This would serve to satisfy items 2, 7 and 8 below.

None of the received items "A", "B", or "C" describe the criteria and process for determining:

- · What a bona fide religious conviction is
- · Which religious organizations are approved, other than Amish or Mennonite

Items 3, 4, 5, and 6 appear to be missing or do not exist. Understandably, a missing item may not have to exist. I request that in this case the missing item just be indicated as "Does not exist."

Send a copy of the procedure used in determining which public or private religious orders have "such bona fide religious convictions".

If none exists, please reply "Item 5 - Does not exist."

6. Missing

Send a copy of the complete list of the determined "bona fide religious orders or sects". If none exists, please reply "Item 6 – Does not exist."

7. Received

Send a copy of all criteria used for determining whether "an applicant is prohibited by bona fide religious convictions".

8. Received

Send a copy of the procedure used in determining whether "an applicant is prohibited by bona fide religious convictions"

9. Received

Send a copy of all of the criteria used to reject an application for reason of failure "to comply with the provisions of this rule" stated within
